A reminder that if you come across a fresh road kill game animal and are able, please claim the animal and notify Chris Mosher. Please stay with the animal while waiting for someone from RRGC game recovery to show up. If the animal is seriously injured, inform the local police authority so that they or WDFW can dispatch the animal. A permit must be obtained from WDFW online within 24 hours. If the animal is left on the side of the road, it will be claimed by others and the Union Gospel Mission will not reap the benefit of a resource.

RAFFLES: Given that the State of Washington requires a Gaming License for raffles, RRGC was unable to conduct raffles at the General Meetings. WOOD DUCK BOXES: The wood duck nesting season is over. Dale efforts captured 14 wood duck hatches/jumps. The video feed that allowed the live jumps to be fed to the internet. The Upstream feed will not be available next year. Dale will be looking for another video feed.

SALMON BOOTH 2018: SALMON

BOOTH 2018: Dale Schielke & Dave Myers The 34rd Anniversary of the Salmon Booth in the Art in the Park Show is over, impacted this year by the HOT weather. Late afternoon/evening sales were minimal to nonexistent. This year each of the two clubs will receive about \$2,418, based on preliminary calculations. The "Salmon Sandwich", in its 20th year, continues to be a good seller. The fifth year of the Chicken Dinner provided a nonfish alternative, but sales were less than anticipated. A total of 306 pounds of salmon fillets were prepared and served as sandwiches or dinners; and ~120 pounds of chicken thighs and breasts were barbequed for dinners. The unused chicken and salmon purchased is being used for both the CBFC and RRGC picnics. We

estimate that we served about 400 salmon dinners, 500 salmon sandwiches, 120 chicken dinners, 280 bottles of water, and 140 bottles of pop. We continue to get many compliments on the dinners and sandwiches. We would like to give *special* thanks to the Riverside Restaurant and Lounge at the Shilo Inn for providing refrigerated space for us to store the salmon and space to marinate the fillets. We cooked the salmon and chicken on the RRGC's towable Traeger grill, which proved to be very convenient and much easier to manage the cooking temperatures. John Pfeiffer and Rich Holton plus their "booth crew" again did a great job with the booth setup, tear down and storage - thanks. Thank you Frank Scopa for the loan of your Smoke Vault used for hot holding, enclosed trailer with freezer, and the Honda generators for supplemental power. We also appreciate the loan of the enclosed trailer from KOE that was used for secure storage of supplies at the park – thanks! Thanks also to Gaylord Pyle for the many years of providing a storage container to store our cookers and associated equipment/supplies needed for the booth. Lastly, but not least, *thanks* to Dave Myers and Frank Scopa for helping on all the shifts plus assisting in delivering and returning all the various supplies used for the Salmon Booth operation.
